Appointment of Nominating Committee for College Board Chair and Vice Chair

Vice Chair Jordan reported that the following Board members have conveyed their willingness to serve on the nominating committee to appoint the College Board Chair and Vice Chair:

From the list of those members who have expressed interest in serving on the nominating committee, Vice Chair Jordan will chose three members to serve on the committee.

The officers of the Thomas Nelson College Board shall be elected annually, by simple majority at the regular meeting of the Board in September. The terms of office shall be for one year, beginning October 1. Incumbent officers shall be eligible for re-election.

Once the members of the committee have been identified, suggestions may be given to them for consideration. The nominating committee will agree on the slate and secure the nominees' permission to stand for election and to serve if elected.

Suggestions may be made in writing to the nominating committee for inclusion in its report provided the nominees are received by the nominating committee at least two weeks prior to the meeting. If accepted by the nominating committee, the candidate will be contacted by the nominating committee and permission received from the person to stand for election and to serve.

COMMITTEE REPORTS

Curriculum, Instruction, and Student Services Committee (CISS)

Ms. Elizabeth Tai, Curriculum, Instruction, and Student Services Committee Chair, reported that the committee did not have a quorum present for its scheduled meeting. She presented the following committee report:

- a. Approval of proposed Career Studies Certificates
 - o **RECOMMENDED ACTION:** On behalf of the committee, Ms.Tai recommended that the Thomas Nelson Community College Board approve the proposed Career Studies Certificates, Manufacturing Technology and Mechatronics Technology, as presented.

The motion was approved.

President Dever reported that the Associated of Applied Science degree in Advanced Integrated Manufacturing Technology, which was approved by the College Board at its December meeting, has now received approval from both the State Board for Community Colleges and the staff of the State Council of Higher Education for Virginia. This means that the associate degree program can start in January 2016 as originally planned.

Ms. Patricia Harris, Program Coordinator, Advanced Integrated Manufacturing (AIM), reported that the U.S. Department of Labor grant will provide equipment and staffing for the Career Studies certificate over the next two years. The program will begin in Fall 2015.

Ms. Scheid expressed her deep appreciation to President Dever and staff for bringing matters forward for consideration by the Board, and for keeping them moving steadily onward.
