Student Grievance and Complaint Form

The Student Grievance and Complaint policy and procedures are the established medium for students to equitably resolve issues/concerns that may arise in college-related programs, processes, and/or activities not limited to academic issues, student services, and administrative concerns. A complaint is the communication of dissatisfaction with a service and or experience. A grievance is alleged unfair or irresponsible behavior including violations of department or college policies.

Using this form, a student may submit a complaint for the following:

- Dissatisfaction with faculty/staff/student
- Dissatisfaction with an experience and/or service
- Dissatisfaction with an environment, physical location an/or space on campus

A student may submit a grievance for the following:

- Final grade appeal.
- Issue with a faculty/instructor, staff member, or another student.
- Issue with a class.
- Issue with a college procedure/process.
- Disruption of protected speech

This form applies complaints and grievances related to

- Title IV of the Civil Rights Act of 1964,
- Family Educational Rights and Privacy Act of 1974,
- Age Discrimination Act of 1975,
- Title II of the Americans with Disabilities Act of 1992, and
- Section 504 of the Rehabilitation Act of 1963
- First Amendment and Free Speech

This form does not apply to Title IX, Code of Student Conduct Violations, and/or Academic Integrity grievances and complaints.
