An appeal is a review of a decision by a resolution to determine whether sufficient cause exists to invalidate the decision. The Student Grievance Governance Committee is the decision maker with regards to appeals. An appeal is not a new hearing. Appeals shall be limited to the following grounds:

- a violation of due process
- bias of the hearing officer/board for reasons other than the stated rationale
- a deviation from the procedures adopted by the institution that had a material and significant impact on the outcome of the process,
- discovery of new and material information that as unavailable at the time of the hearing, and
- sanction(s) that are disproportionately severe or inappropriate for the violation

All appeals must be submitted within 5 workdays of the receiving the outcome of the formal Title IX, Student Conduct, Academic Integrity, and/or Student Grievance & Complaints process. Students are afforded one appeal per case. The decision of the appeal is final.
